## AQUATE<sup>®</sup> ORGANIC TE w/o Se

### 1. PRODUCT DESCRIPTION:

AQUATE<sup>®</sup> ORGANIC TE w/o Se is a PREMIXTURE of nutritional additives on carriers.

### 2. REGULATORY STATUS:

Premixture of feed additives belonging to nutritional additives (Regulation (EC) No. 1831/2003). Functional group: Compounds of trace elements.

### 3. GUARANTEED ANALYSIS:

#### 5. DIRECTIONS FOR USE:

Add AQUATE<sup>®</sup> ORGANIC TE w/o Se at a rate of 5.46 kg/tonne of complete feedingstuffs.

#### 6. STORAGE AND SHELF LIFE:

Store in a cool, dry place. Open containers should be resealed. Shelf life under these conditions is 12 months.

#### 7. SAFETY RECOMMENDATION:

Causes serious eye damage.

Harmful to aquatic life with long lasting effects.

Avoid release to the aquatic environment.

Wear eye protection, protective clothing, protective gloves.
